In consequence, submission of original research papers in English with a minimum volume of 21 000 characters is expected. The papers are to be prepared according to the **attached requirements**. The manuscripts will be subjected to double reviewing and will be published only after approval.

28 February 2022 – <u>registration</u> deadline (registration will open on 15 January 2022)

30th September 2022 - registration fee:

- > 800 PLN the fee includes paper publishing, meals and conference events, accommodation in Hotel Gromada Pila as well as all conference materials,
- ➤ 600 PLN participation in the conference, full board and accommodation (Hotel Gromada in Pila), conference materials


