Objective: The objective of the course is to introduce students to the methods, procedures and processes of research and application of principles, concepts and institutes in the field of international criminal law; mastering specific legal skills in the system of criminal law protection of peace and international security; to be able to interpret and apply international and national legal regulations in the field of international criminal law.			
Outcome: After passing the exam, the student adopted theoretical knowledge in the field of international criminal law; understands the essence of criminal law institutes in the field of international criminal law and the possibility of their adequate application; mastered specific legal skills in the system of criminal law protection of peace and international security; He has been trained in the interpretation and application of international and national legal regulations in this field.			
Contents of the course: Theoretical classes: 1. Introduction to the case; 2. The content, content and legal nature of international criminal law; 3. Sources of international criminal law; 4. Historical development of international criminal law; 5. Basic principles of international criminal law; 6. International criminal offense (object and subject); 7. Criminal liability; 8. I mean, the elements and the basis of exclusion of guilt; 9. Characteristics, historical development, purpose and types of penalties for international criminal offense; 10./11. Characteristics and forms of manifestation of certain criminal offenses against humanity and international law in international and domestic criminal law; 12. Historical development, organization and jurisdiction of the organs of the international criminal justice; 13. The course of criminal proceedings before the International Criminal Court; 14. International Criminal Legal Aid; 15. Execution of foreign court decisions. Practical classes: Closer clarification of some of the topics addressed in the lectures, with particular reference to the interpretation of key legal concepts and institutes in the field of international criminal law. Discussion of selected topics with the active participation of students. Preparation of colloquium and exams. Evaluation of realized teaching and analysis of its results.
