Objective: The objective of the course is to introduce students to basic concepts of family law. Acquiring knowledge about institutions and institutes of family law in the legal system of Serbia. Training students to identify relationships and differences of family law and other branches of civil law.			
Outcome: After passing the exam, the student has adopted theoretical knowledge in the field of family law and understands the basic institutes of family law in our legal system; able to identify and explain relationships and differences between family law and other branches of civil law; able to apply adequate legal norms to a particular legal relationship in their professional work.			
Contents of the course: Theoretical classes: 1. Introduction to family law. 2. Basic concepts; The family; Relation; Personal name; 3.Sources of family law; 4. The aim, content and structure of the family law; 5.Black and partner law-concept and principles; 6. Dating marriage; 7.Date of marriage; Termination of marriage; 8.Vanbračna zajednica; 9. Community of the same sex; 10. The law of the law; 11. Parental rights; 12. Identification of parenting; 13. Relations between relatives; 14. Domestic violence; 15.Usvojenje; Fertilizers; Guardianship. Practical classes: Closer clarification of some of the topics addressed in lectures, with a special emphasis on the interpretation of key legal concepts and the institution of family law; Simulation of work from court practice. Discussion of selected topics with the active participation of students. Preparation of colloquium and exams. Evaluation of realized teaching and analysis of its results.
